
### Notice Inviting Quotation for contract of College Canteen

Annexure – A

General Terms and Conditions

1. The contractor/vendor must be registered under goods and services tax (GST). Proof must be enclosed.
2. The Contract for College Canteen will be awarded for a period of one year. On satisfactory services the contract may be renewed.
3. The contractor will have to pay a License fee of Rs. 5,000/- **Per Month** (non-refundable).
4. The contractor is required to deposit a sum of Rs. 60,000/- (refundable) as Security deposit.
5. The College will charge Rs. 2,000/- **Per Month** as water charges. Electricity charges will be as per sub meter reading.
6. The Contractor will not transfer, or assign, or sub-contract the Contract to any other person under any circumstances. The Contractor has to be physically present in the Canteen on all working days.
7. The Contractor has to, if need be, arrange for obtaining the necessary permit for running the canteen from the concerned authority.
8. The College authorities reserve the right to review the working of the Canteen from time to time. If the Contractor fails to keep up with the terms and conditions of the Contract or it's working is not satisfactory in the view of the authorities, the College may terminate the contract after giving the Contractor 15 days notice.
9. The Contractor will have to sign an agreement with the College regarding the **comprehensive terms of the contract** which will be provided to the successful contractor at the time of awarding the contract.
