- 2. Inflation and Volatility in Global Crude Prices.








### FIC ARSD's BLOG



## CORE FRAMEWORK FOR CONSULTING



### Context Understanding (C)

Objective: Establish a deep understanding of the client's industry, business environment, and specific challenges.

#### Steps:

- Conduct market and competitive analysis.
- Identify key industry trends and disruptions.
- Understand client's business model, value chain, and financials.

**Output:** Context map highlighting the business environment, opportunities, and threats.

#### Objective Setting (O)

Objective: Define clear, achievable objectives that align with the client's vision and strategic goals.

#### Steps:

- Engage stakeholders to clarify strategic priorities.
- Develop SMART (Specific, Measurable, Achievable, Relevant, Time-bound) objectives.
- Align objectives with the client's long-term vision.

**Output:** Objective statement document with aligned goals.

#### Root Cause Analysis (R)

**Objective:** Diagnose the underlying causes of the challenges or inefficiencies the client faces.

#### Steps:

- Use frameworks like the 5 Whys, Fishbone Diagram, or SWOT Analysis.
- Gather data through interviews, surveys, and internal analysis.
- Identify bottlenecks and critical pain points.

**Output:** Root cause report detailing the main issues and their origins.



#### Execution Planning (E)

Objective: Develop and implement actionable strategies to achieve the set objectives.

#### Steps:

- Create a strategic roadmap with phased implementation.
- Design key performance indicators (KPIs) to measure progress.
- Identify resources, capabilities, and partnerships needed.
- Plan for risk management and mitigation strategies.

**Output:** Execution plan with timelines, responsibilities, and KPIs.

#### Feedback Mechanism (F)

Objective: Ensure continuous improvement, adaptability, and alignment throughout the consulting process.

#### Steps:

- Implement regular feedback loops with key stakeholders (e.g., weekly/monthly checkins)
- Use surveys, interviews, and performance data to gather feedback on progress and impact.
- Adjust strategies and execution plans based on feedback.
- Document lessons learned and best practices for future projects.

**Output:** Feedback report highlighting insights, adjustments made, and overall progress toward objectives.

## PROJECT PARCHAM



Parcham is the Social project Unit of FIC ARSD under which FIC undertakes initiatives to spread financial literacy and contribute its share to society. The Social Project department of FIC ARSD is its initiative corresponding to CSR, working with the intent of "Giving back to the society".

#### Some of the initiatives are-

- Financial literacy drives for women and children
- Study visits for interaction with the Director and Assistant Director of NCUI and visits to NCUI Haat and incubation centre.

## WHAT WE DO



#### WOMEN EMPOWERMENT DRIVE

FIC ARSD's Project Parcham organised a Women Empowerment Drive at JJ Camp in December 2023, reaching 60–70 women with 7–8 volunteers. They explained key government schemes like the Delhi Ladli Scheme, Widow Pension Provisions and Sukanya Samriddhi Yojana through Group Discussion, promoting awareness and financial knowledge. This initiative reflects FIC ARSD's aim towards contributing to the community's awareness and understanding of key initiatives supporting women's empowerment.

#### **UDGAM DRIVE-I**

FIC ARSD's 'Project Parcham' organized its inaugural Financial Literacy Drive "UDGAM" in November 2023. The first drive benefitted 16 youngsters aged 15–18 from Adhiyagya NGO, Sarita Vihar. Eight volunteers from FIC shared crucial financial insights and concepts with students, aimed to empower youth by enhancing their financial knowledge. The drive concluded, leaving an educational impression and meaningful interactions with the students. The success of this drive ignited a strong desire to conduct more such drives.

#### UDGAM DRIVE-II

Under Project Parcham, FIC ARSD organized the Second UDGAM Financial Literacy Drive on December 2, 2023. Eight volunteers from FIC ARSD conducted an interactive session, imparting foundational financial knowledge to around 35 youngsters aged 15–18 years from Ishwar NGO, Saket. The main aim was to empower youth with essential financial skills and impart financial knowledge to the students. FIC ARSD aspires to make a lasting impact on society through such initiatives.













## FIC SUMMIT'23

#### 18th September 2023

The Finance and Investment Cell of Atma Ram Sanatan Dharma College, University of Delhi hosted the FIC Summit'23 on the 18th of September, 2023 intending to build connections and encourage professional development along with the essence of financial expertise through a series of educational and empowering activities such as Speaker Session by Bhanu Pathak, who has a community exceeding 1.5 million followers across social media platforms, Quiz Competition with prizes worth ₹1.5 Lakhs and Networking Zone to promote collaboration among FIC's. The event attracted 19+ finance societies across Delhi University. Filled with zeal and unparalleled passion, the event was a combination of the following engagements:

- 1. Speaker Session
- 2. The Finance Quiz
- 3. Networking Zone





















#### SPEAKER SESSION

The event commenced with an impactful speaker session by renowned financial influencer Mr Bhanu Pratap, known for sharing financial wisdom through personal experiences and rigorous research. He boasts a substantial social media community exceeding 1.5 million followers across social media platforms. This session covered essential topics like content creation, personal marketing, the link between content and social media marketing and the importance of originality and authenticity in the current digital sphere. The positive student feedback reaffirmed its alignment with FIC's objectives of skill enhancement and professional development.



#### THE FINANCE CHALLENGE

The event was followed by The Quiz Competition involving 15+ FICs from various colleges across Delhi University. The quiz tested the financial expertise of the participants across diverse topics, from terminologies to behavioural finance. The initial MCQ quiz was a thrilling battle against time on Mentimeter, setting the tone for an intellectually stimulating challenge. Subsequently, 12 teams advanced to a second round, merging into six entities for a one-on-one clash of financial intellect, in the end, FIS SBSC secured third place, D-STREET claimed second, and FIC Aryabhatta emerged victorious after six thrilling sub-rounds.



#### **NETWORKING ZONE**

Lastly, the event was enthralled by a distinctive segment called The Networking Zone which facilitated collaboration among participants. Positioned before the Merger Round of the quiz competition, it served as a platform for FICs to discreetly showcase their strengths and identities. Each FIC shared hints about their college societies anonymously, revealing details on paper for others to guess. The event host presented these hints and unique selling propositions, encouraging FICs to identify the societies. Correct guesses or unidentified societies prompted brief presentations about the societies, their projects, and aspirations. The Networking Zone succeeded in promoting collaboration and relationship-building among participants.



## **MONETAIRE'24**

FIC ARSD organized its annual Flagship Event: Monétaire'24 with great zeal and enthusiasm on March 1,2024. The event was a culmination of various informative and helpful sessions, panel discussions and cutthroat competitions. the event was a combination of the following engagements:

#### **DUEL OF DOMINATORS**

The Finance and Investment Cell of ARSD recently conducted a captivating event- the DuelofDominators(DoD)- which attracted over 100 participant teams fromall across the Delhi-NCR eager to showcase their strategic and financial acumen. Teams comprised individuals from diverse backgrounds ,each contributing unique strengths to the competition. The gameplay of DoD involved teams being equipped with virtual money to strategically purchase weapons, balancing offense and defense to ensure they retained sufficient funds for subsequent rounds. The success of the preliminary round sets the stage for even more thrilling competitions in the upcoming rounds of the DoD. As the competition progresses, the challenges will become more complex, testing there silence and ingenuity of the participating teams. The FIC Duel of Dominators Preliminary Round was a resounding success, bringing together talented individuals and teams to engage in virtual battle of wits and strategy. As the competition advances, it promises to deliver heightened excitement and show case the remarkable capabilities of the participants. FIC remains committed to fostering innovation and providing a platform for dynamic and challenging competitions.

#### PANEL DISCUSSION

The Panel Discussion included vast stretch deliberation on the topic "Starup Ecosystem and emergence of Fintech" with our esteemed panelists Rahul Lakhmani (founder and CEO of Skiffy Solutions), Rajiv Sikka (Former CEO of Indian Oil- Adani Gas Pvt. Ltd.) and Saurabh Jain (Founder of Fun2do labs and Startuplearn.org and Former Vice President at Paytm). Mr. Rahul Lakhmani being a navigator of fintech landscape discussed the current state of the Starup ecosystem in fostering innovation and how his company addressed a market need or disrupted traditional financial services.

The audience and panelists themselves condensed the epicentre of scaling startups and navigated regulatory frameworks aiming to innovate in areas traditionally underserved by financial institutions.









## **MONETAIRE'24**

## CASE COLOSSEUM: COVET.CHALLENGE.CHAMPION

Case Colosseum, a comprehensive case study competition was organized by the Finance and Investment Cell of ARSD College under its flagship event Monètaire 2024. The competition was divided into two rounds.

The first round was a quiz competition held on 25th February which attracted over 220 registrations on Unstop with participation from premium institutes like IITs and IIMs and even a team from Indonesia. The top ten teams were selected for the subsequent round, the Case Study Round.

In the final round which was held on 2nd March, the qualifiers were given a Case Study on 'Digital Payments' which they had to solve and pitch their innovative ideas to the panel of judges comprising of Rahul Lakhmani (an alumnus of IIT Bombay and and CEO and founder of Skiffy), Akhil Iyer (CA, CMA and Cofounder of edZeb) and Mohit Geat (an ISB alumnus and exconsultant at McKinsey and Company).

Winners were soon announced by the judges. The event received positive feedback from the participants as well as the judges. With this began the celebration of the successful completion of yet another event, Monètaire 2024. FIC ARSD looks forward to conducting many such informative and intellectual events and competitions in the future.
