The Governing Body is of the opinion that in the present case. Order No. 395 dated 22.12.2023 has been passed by the Disciplinary Authority i.e., the Governing Body of the College whereby a punishment under Rule 63 of the Rules is imposed upon Smt. Aruna Kumar. Therefore, by virtue of the Rule 76(1)(b) of the Non-Teaching Employees (Terms and Conditions) Rules-2013, the Governing Body of the College cannot act as an Appellate Authority and decide an appeal of its own order. Even otherwise the general principle of law prohibits the Governing Body sitting an appeal over its own order.

After due discussion, deliberation and consideration and in the light of aforementioned position of the Law, the Governing Body found that the present appeal filed by Smt. Aruna Kumar under Rule 75 of the Rules is not maintainable. Therefore, the Governing Body unanimously dismissed the appeal filed by Smt. Kumar.

Further, the Governing Body authorizes the Chairman, G.B. to serve the order to Smt. Aruna Kumar in this regard.
